Did you know that taxes can be paid at the 7-11?

In a program aimed at individual taxpayers who lack checking accounts or credit cards, the IRS has unveiled a partnership with retail stores (currently only 7-Eleven) to allow these taxpayers to pay their federal tax bill in cash (IR-2016-56). Called **PayNearMe**, taxpayers can pay up to \$1,000 a day at over 7,000 **participating stores** for a \$3.99 fee. The IRS says that many of the stores are open 24 hours a day, 7 days a week.
